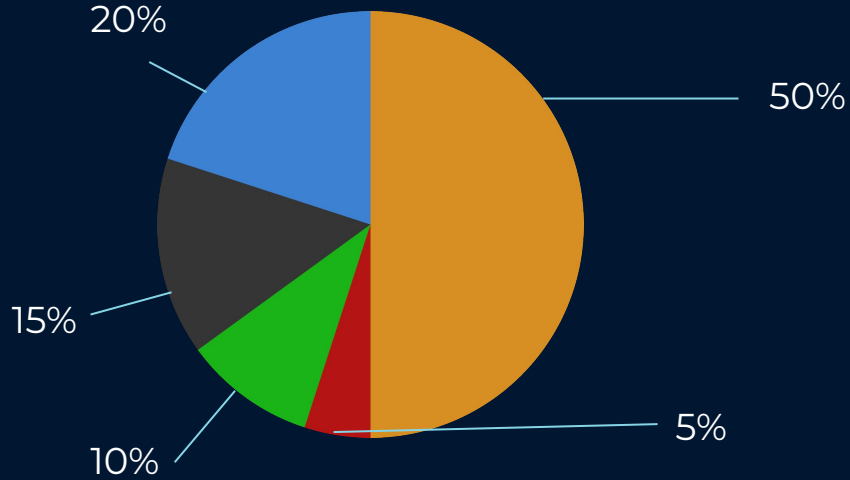


Tokenomics

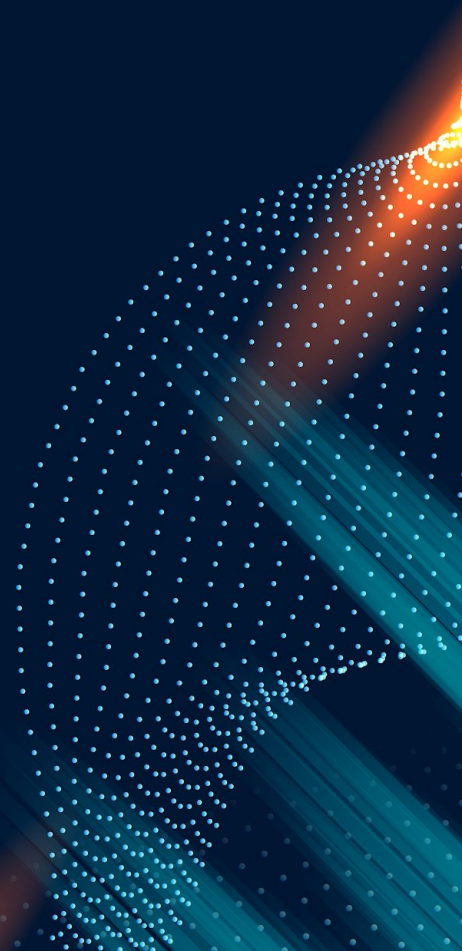

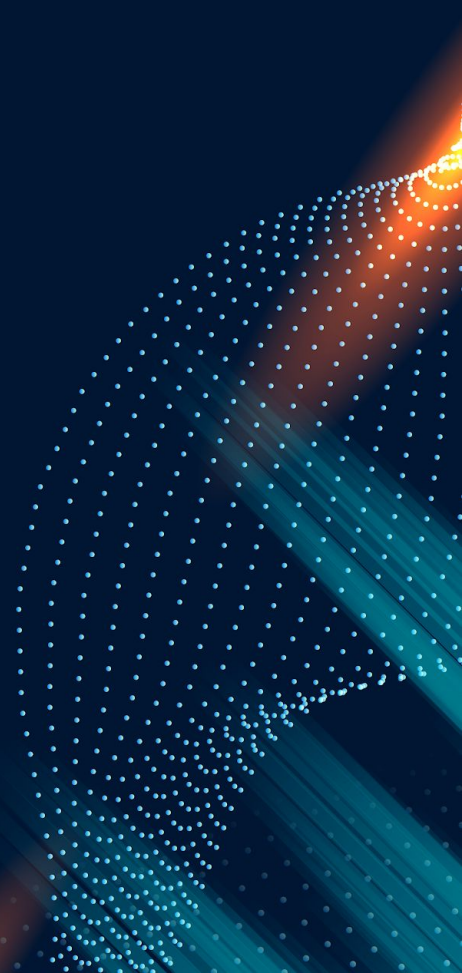
